After your ride, you will have the opportunity to talk to the judge, get exercises to help improve your test, then ride it (or parts of it) again. You have 30 minutes in the ring with the judge. You and the judge will decide how to best use your time! Remember that Dressage and Western Dressage tests are dated 2019. Eventing is dated 2022.
